Mr. Lynd made a motion to approve the Clerk/Treasurer's Financial Report, Revenue/Expenditure Account Status Report, and the Bank Reconciliation ending Sept. 30, 2019. Mr. Smith seconded. Roll call -- yes by all.

Fire Dept. Report – Chief Mark Goodall reported that the new four door mini rescue pumper for the village will arrive in April of 2020. The purchase has been made through Pierce Manufacturing Inc., who has an Ohio state procurement contract #800721. Chief reported an increase in call outs, especially for EMS help. He requested Chuck McFarland be approved as firefighter to the department. Mr. Smith made a motion to accept Chuck McFarland as a volunteer firefighter to the South Point Volunteer Fire Department. Mr. Austin seconded. Roll call: Arthur-yes, Austin-yes, Cogan-yes, Lynd-yes, Smith-yes

Police Dept. Report – Chief Chris Majher reported that police officer Larry Large has filed for retirement with OPFPF as of 10/1/2019. Chief noted that he will be a hard officer to replace, and will be missed. A state grant for police body armor has been approved for approximately \$7,000 with a village match of \$1,500.

Village Administrator, Russ McDonald reported the water usage for September was 24 million gallons and processed 22 million gallons of wastewater. He stated the fire hydrants have been painted throughout the village and recently the valves have been exercised and flushed. In the street department, core samples have processed on Fitzpatrick heights concerning the foundation soil which the road is paved on. The samples consisted primarily of sand. Engineering will continue on fixing drainage issues on the road first.

Other items discussed:

- Illegal dumping was reported on the railroad lot off N. Kenova Rd. along with very high weeds on the 114 Lawrence Ave property.
- The mayor appointed a committee consisting of Village of South Point residents Randy Guthrie, Lisa Irish Rivers, Allen Wagner and council member Marlene Arthur. The purpose of the committee is to reform our rescinded vicious dog ordinance in order to comply with HB 14 and the Ohio Revised Code. They will have until December's council to present the new ordinance before council.
- October 5th will consist of the Village Wide Yard Sale, Fire Dept. Pancake Breakfast beginning at 7:00AM and Shred Day 11:00-2:00 p.m. for village residents at the old Family Dollar parking lot.
- 415 Solida Road Municipal Bldg. loan will be paid off this month.
- White Cottage Cemetery's new addition had its first internment recently.
- We earned \$738.12 on our StarOhio investment in Sept. at 2.25% interest.

After completing all items on the agenda, Mayor Gaskin dismissed the meeting at 8:27 PM
